I.C. 35-42-3-3(a) and I.C. 35-41-2-4 and I.C. 35-42-3-3(b)(1)(C) and I.C. 35-41-2-4

Count II:

on or about July 4, 2020 in Monroe County, State of Indiana, Jerry Edward Cox II did knowingly or intentionally touch Vauhxx R Booker in a rude, insolent, or angry manner by striking him, resulting in moderate bodily injury, to wit: a mild concussion. I.C. 35-42-2-1(c)(1) and I.C. 35-42-2-1(e)(1)

Count III:

on or about July 4, 2020 in Monroe County, State of Indiana, Jerry Edward Cox II did communicate a threat to Frederick Max Walsh, another person, to wit: Jerry Edward Cox II said that he was going to punch Frederick Max Walsh in the face, with the intent that Frederick Max Walsh be placed in fear that the threat will be carried out. I.C. 35-45-2-1(a)(4)

Count IV:

on or about July 4, 2020 in Monroe County, State of Indiana, Jerry Edward Cox II did

knowingly or intentionally touch Brennan Golightly in a rude, insolent, or angry manner by striking the cell phone in Brennan Golightly's hand. I.C. 35-42-2-1(c)(1)

Count V:

on or about July 4, 2020 in Monroe County, State of Indiana, Jerry Edward Cox II did knowingly or intentionally touch Ian Watkins in a rude, insolent, or angry manner by striking him. I.C. 35-42-2-1(c)(1)
