- Spring tax bills are due Monday, May 10th and Wednesday, November 10th.

- All county offices are closed.

All payment options are listed on the reverse side of the tax bill.

- 4. Drop box located outside the courthouse near the north doors.
- 5. Drop off at one of 3 local bank branches collecting on our behalf. First Financial Bank and Farmers and Mechanics Federal Savings and Loan.
- 6. By appointment. County offices are closed to the public. Appointments are reserved for cash and check payments only. Appointments must be made prior to arrival. Appointment times are limited due to staff availability. Other payment methods are preferred to making an appointment. Call 349-2530 and press 6 to speak to a staff member.
