Thank you for your patience. After speaking with you directly about your request and what exactly you were looking for, I was able to obtain the following information from our Crime Analyst.

170 cases total in 2020, compared to 172 in 2019.

52.44% increase in the number of crimes committed with a firearm 125 of the 170 cases reported the use of firearms.
