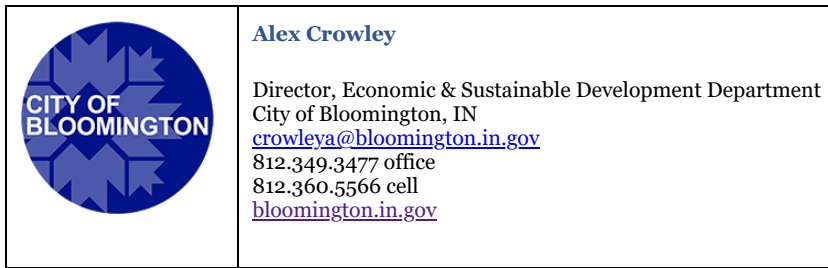

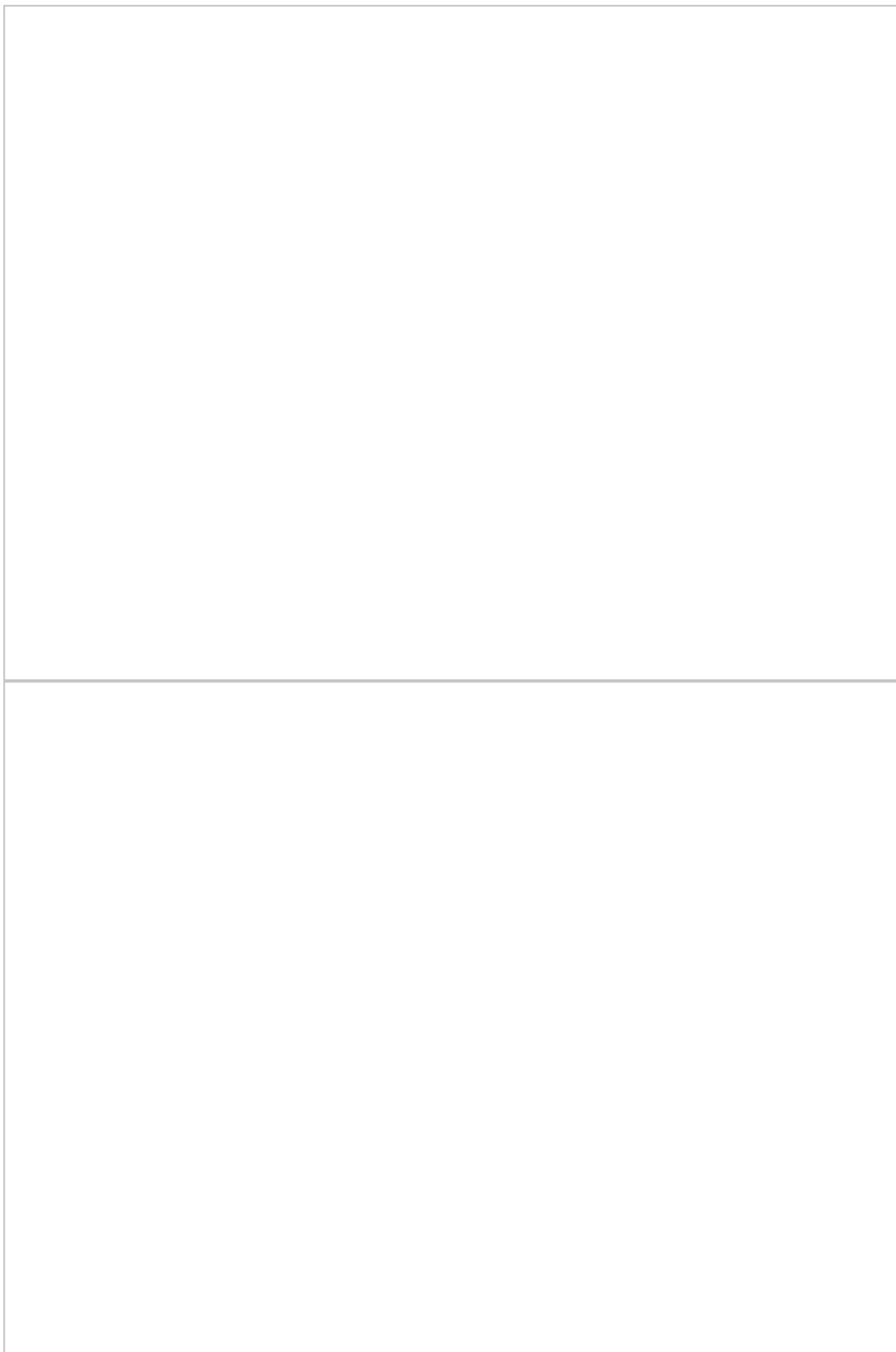

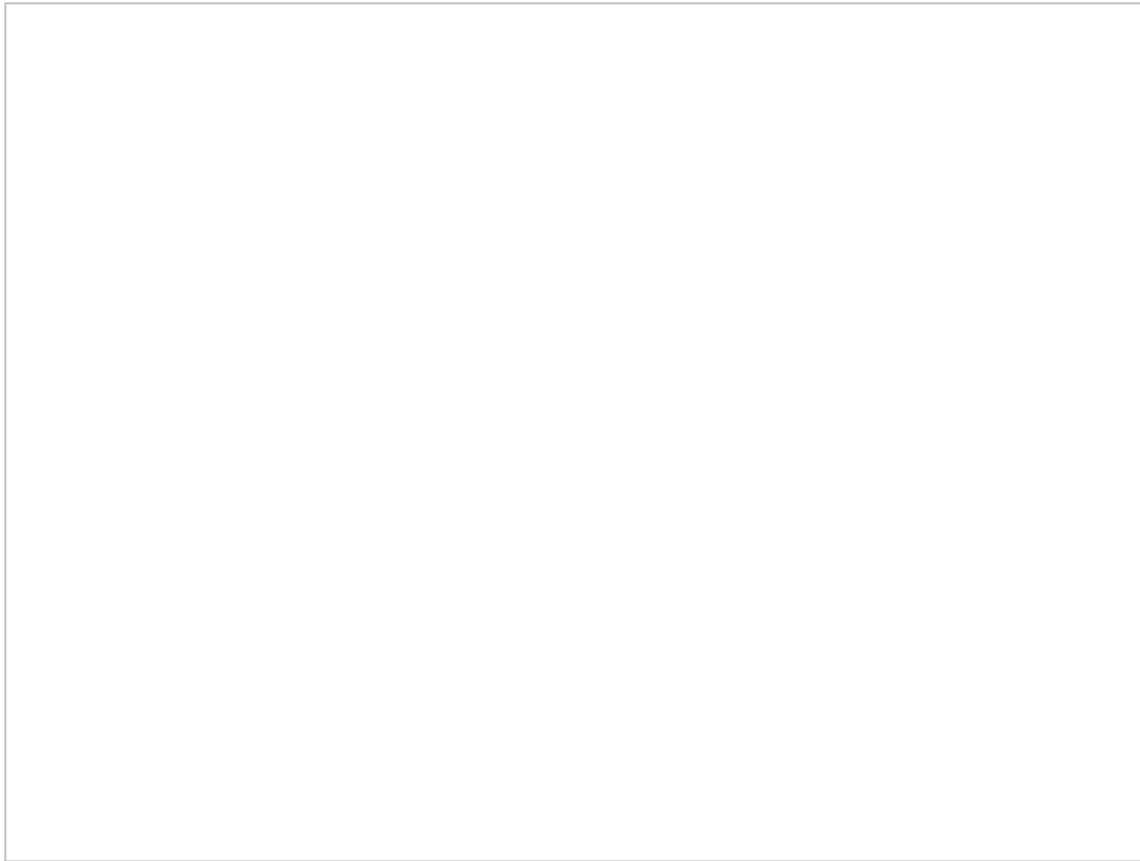
The electronics were still dry so some Lime juicer will be able to find it. I don't know where the local Lime shop is, else I would have dropped it there.

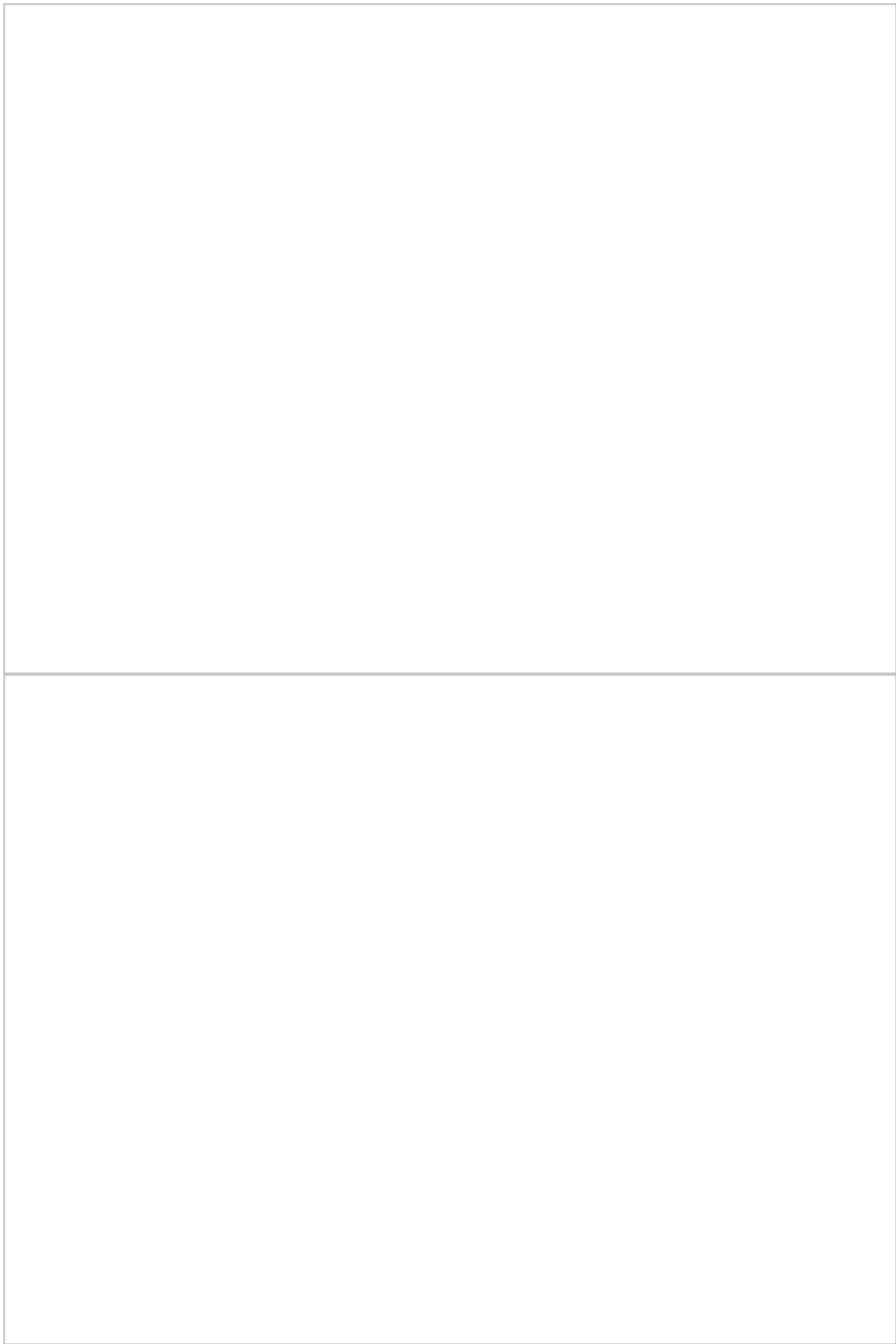

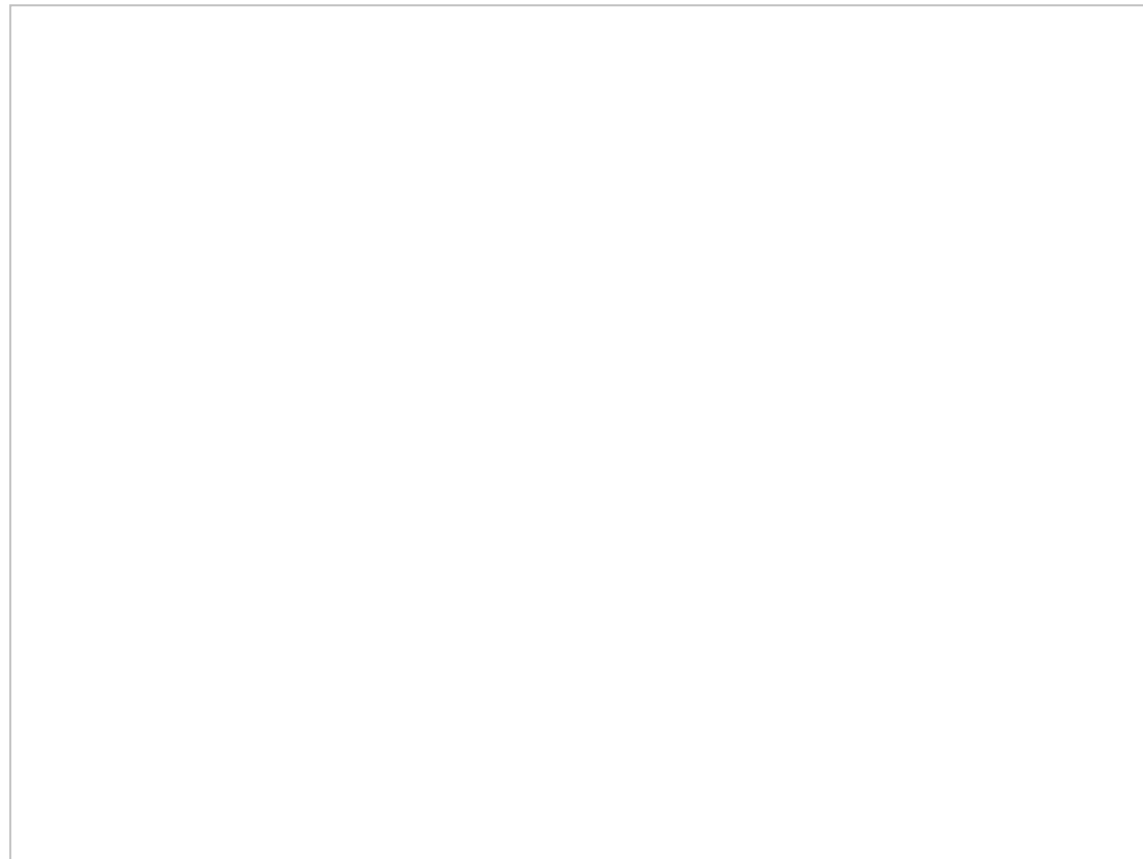

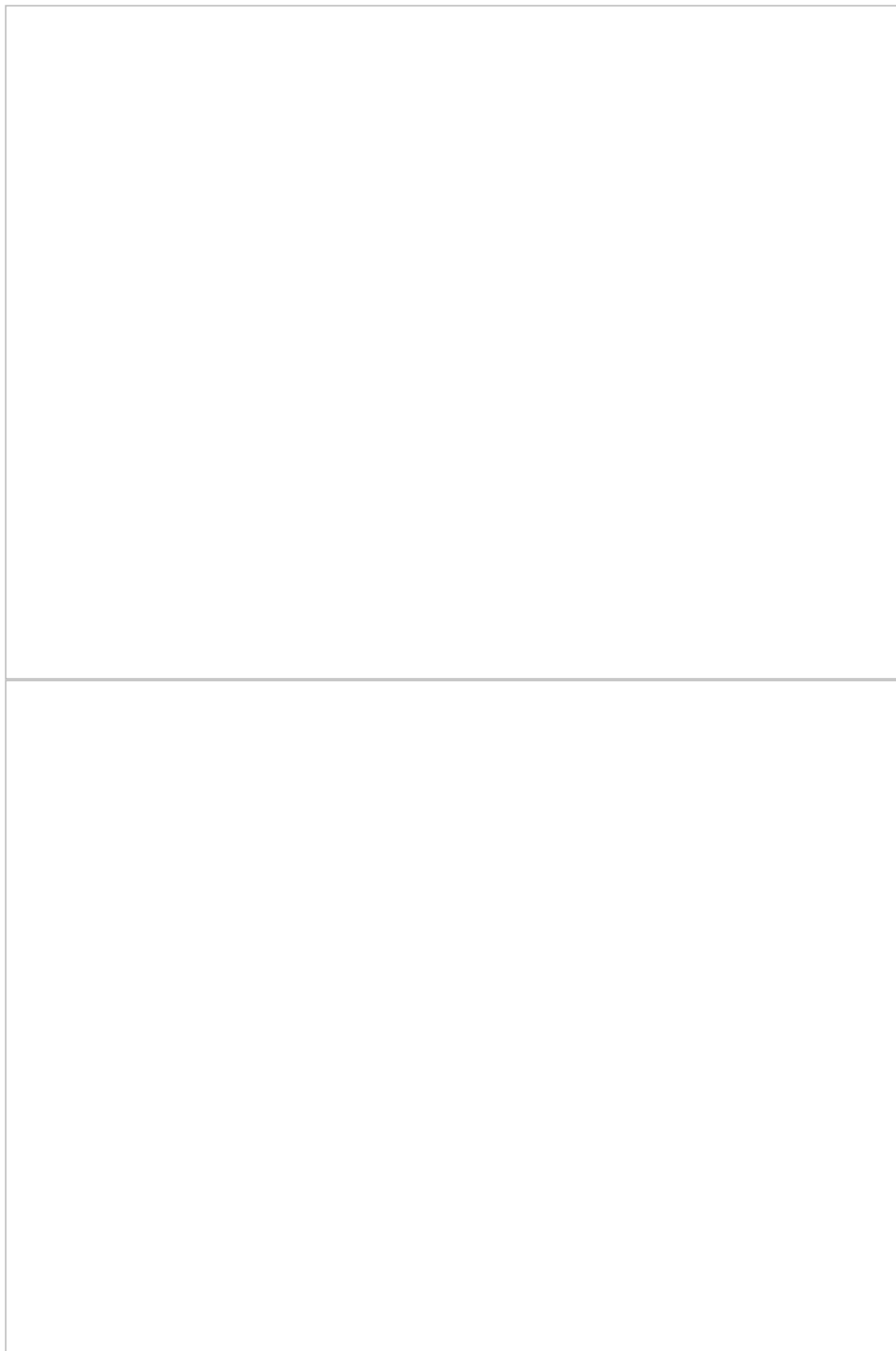
