There is a fee table and all of the requirements listed in the link to the code.

- There is a \$100 application fee, which we have done by neighborhood for other fiber contractors.
- Boring is \$0.10 per lineal foot.
- Excavation in the street is \$1 per square foot.
- Sidewalk reconstruction and excavation in the tree plot are both \$0.10 per square foot.
- The bonding needs to be for the cost of work within the right of way plus 25%. How much would it cost to make the City whole again if they abandon all of their work before it's completed, plus 25%.

Those are the main things. Closures do have a fee as well, listed in a table.
