Hi Mr. Lucas -

I wanted to send you a few notes since I think a lot of this labor will land in your lap:

I wanted to thank you for all the help you have been to me in my many presentations before the council.

I apologize for the work this drama creates for you. I decided to use drama as a tool to make a political point, but I regret making a headache for people like you.

I want you to know I do not intend to procedurally challenge whatever measure you come up with to un-appoint me. I have no idea what struggle you face on that front but just in good faith I want you to know I do not doubt the authority of the council to un-appoint me and I promise to you personally that I will not challenge that authority.

On the other hand, I will not resign. Creating the spectacle of the council kowtowing to Elm Heights' petty outrage is the purpose of my conduct.

And I can't imagine it will come to that but just to be clear, if the council does try to remove my ability to participate in public comment as an unaffiliated member of the public, I will challenge that strenuously.

preside over. I also do not resent the possibility of being removed from the traffic commission. I am there to get work done and this confrontation with Elm Heights already damaged that work before I came up with the brilliant(?) idea of being a lightning rod for their bullying.
