**INSTRUCTIONS:** This form is used by a nominee chosen in the municipal primary, nominated by petition, or chosen by a convention who wishes to remove the nominee's name from the municipal election ballot. This form is also used by a write-in candidate who wishes to withdraw.

**DEADLINE:** Except as otherwise provided by law, this form must be filed with the appropriate circuit court clerk by NOON, July 17, 2023.

**EXCEPTION: For Candidates Seeking Office in Small Towns Outside Marion County:** A candidate who files a declaration of candidacy for a town office in a town with a population of less than 3,500 which has not conducted a town primary in 2023 may withdraw by filing this statement by **NOON, August 1, 2023.**

**EXCEPTION: For Candidates Nominated by Small Town Political Party Convention:** A candidate who files a declaration of candidacy for a town office in a town with a population of less than 3,500 may withdraw by filing this statement by NOON, August 1, 2023. A candidate nominated by a town convention of the Democratic, Libertarian, or Republican Party must file this withdrawal with the circuit court clerk or town election board no later than NOON, three (3) days after the adjournment of the town convention.

**CANDIDATE WITHDRAWAL**
