Dear Property Owner:

The City of Bloomington is in the process of considering seven (7) areas for annexation, which are identified on the enclosed map. Although these areas are already part of the Bloomington community, they are not within the City’s municipal boundaries at this time. The annexation process – if completed – would bring the areas within the City’s boundaries. As currently proposed, the annexations would not take effect until 2020.

This notice is being provided to you because, according to available property tax records, you are a landowner in the proposed “South-West Bloomington Annexation Area” identified on the enclosed map. Please note that you may receive multiple notices if you own more than one property in the annexation areas.

Before introducing annexation ordinances, the City is conducting an outreach program in an effort to inform citizens about the proposed annexations. The City will hold six (6) public meetings to provide citizens with information concerning (a) maps of the proposed boundaries of the seven annexation territories, (b) proposed plans for the extension of services in the annexation territories, and (c) the expected fiscal impact on taxpayers in the annexation territories. The dates, times, and locations of the outreach program meetings are as follows:

If you are unable to attend one of the meetings, the maps, proposed services, and fiscal impact information are also available on the City's website, located at [bloomington.in.gov/annex](http://bloomington.in.gov/annex), or during regular business hours at the Bloomington City Hall, 401 N Morton Street, Bloomington, Indiana 47404.

After the public outreach program, the next formal step for the City is to introduce ordinances for one or more of the proposed annexations, after which the City would hold a public hearing at a later date to be determined.
