COMES NOW Margaret Clements, and being duly sworn upon her oath, states as

#### follows:

My name is Margaret Clements and I am an adult resident of Monroe County,
 Indiana. I have personal knowledge of the facts set forth in this Affidavit.



- I am the President of County Residents Against Annexation, Inc., an Indiana nonprofit corporation.
- 3. As of May 11, 2022, the City of Bloomington's Showers Building, which houses many City of Bloomington governmental administrative offices, limited and prohibited public access due to concerns about the spread of COVID-19. A photograph of signs restricting public access to the Showers Building on May 11, 2022 is attached hereto and made a part hereof as Exhibit A.
- The City of Bloomington's prohibition on public access to the Showers Building was also in effect between October 8, 2021 and January 6, 2022.
- 5. As of May 27, 2022, the City of Bloomington Utilities Office, located at 600 E. Miller Drive, Bloomington, Indiana, also limited and prohibited public access due to concerns about the spread of COVID-19. A photograph of a sign posted on the City of Bloomington Utilities Office door as of May 27, 2022 is attached hereto and made a part hereof as Exhibit B.
- The City of Bloomington's prohibition on public access to the Utilities Building was also in effect between October 8, 2021 and January 6, 2022.
- 7. On May 6, 2022, John Hamilton, Mayor of the City of Bloomington, Indiana, issued a "2021 Budget Goal Report" that reported the status of budget goals for the City as of the end of 2021. Copies of excerpts from the 2021 Budget Goal Report are attached hereto and made a part hereof as Exhibit C.

8. In his letter to the members of the Common Council of the City of Bloomington dated May 6, 2022, Mayor Hamilton stated the following with respect to the City of Bloomington in 2021:

"COVID-19 dramatically affected Bloomington both in real-time and in ways still unseen. This Report is evidence of the challenges faced by the pandemic. I commend City leaders and staff for their resilience and commitment to delivering City services during a once-in-a-lifetime event."




